1. Terms & Conditions

These terms and conditions govern your (**You/Attendee**) involvement in, purchasing of, registration for, and attendance at LambEx26, an event held and organised by 28 National Limited (ABN 37 661 170 985) (**LambEx/Us/We**) (the **Event**). It is Your responsibility to review these terms and condition prior to the registering and attending the Event. By registering or attending the Event, You agree to be bound by these terms and conditions.

2. Conference Registration

2.1 Registration

On Behalf of Others

If You are registering for the Event on behalf of another person, it is Your responsibility to ensure that the Registrant is aware of these terms and conditions. By completing the registration for the Event, you are warranting that you have the Registrant's full authority to register them, have made the Registrant aware of these terms and conditions, and that they have accepted them.

Registration Confirmation

Your completed registration and successful payment will be acknowledged via email with confirmation of your requirements according to your registration form. Your registration will only be processed or confirmed once payment has been made. Please contact us at lambex@arinexgroup.com if you do not receive your confirmation as this may affect future communications from us. All registrations must be paid in full by the close date to secure the discounted rates.

Ticketing & Transfers

Tickets are issued for the personal use of the registered attendee and may not be resold, auctioned, advertised for resale or transferred for commercial gain. LambEx reserves the right to cancel any ticket obtained through unauthorised resale channels without refund.

Virtual tickets are issued for the personal use of the registered attendee only. Virtual tickets are non-transferable and may not be shared, resold, auctioned, advertised for resale or transferred to any other person. Access credentials issued for the virtual platform are personal to the registered attendee and must not be shared under any circumstances.

Name Badges

Each delegate will receive a name badge when they check in at the registration desk on site at the event. The badge will be your official pass to obtain entry to all plenary sessions and related LambEx sub-events. You are responsible for always having your badge clearly visible to obtain entry to plenary sessions and related LambEx sub-events while onsite.

Virtual Platform Access

Virtual delegates will receive access to the LambEx26 OnAIR platform via login credentials sent to the registered email address prior to the Event. Your login credentials are personal to You and serve as your official pass to access the virtual platform. Access is restricted to a single registered device. You are responsible for keeping your credentials secure and must not share them with any other person. LambEx reserves the right to revoke access without refund where credentials are found to have been shared or attempted to be used across multiple devices.

2.2 Cancellation & Refund Policy

- (a) Cancellations must be notified in writing to the following email address lambex@arinexgroup.com. Cancellations received before 21st May 2026 will incur a \$150 cancellation fee. Cancellations received between 22nd May 2026 – 6th June 2026 will incur a 50% cancellation fee. No refunds will be issued for any registration cancellations made on or after 7th June 2026.
- (b) If You are unable to attend the Event, a replacement attendee may be sent in Your place at no extra charge. If you wish to request approval to send a substitute

to the Event or to another person in your place, you must make such a request to LambEx at lambex@arinexgroup.com in writing three (3) days prior to the Event.

(c) Welcome Function & Gala Dinner Tickets

Tickets purchased for the Welcome Function and/or Gala Dinner are subject to the same cancellation, refund and substitution timeframes set out above. Requests for cancellation, refund or substitution of Welcome Function or Gala Dinner tickets must also be submitted in writing to lambex@arinexgroup.com. No refunds will be issued for Welcome Function or Gala Dinner ticket cancellations made on or after 7th June 2026.

(d) LambEx on Tour

Offsite tour tickets are sold separately to conference registration and are subject to the Offsite Tours terms set out below in clause 4.5. The conference cancellation and refund policy does not apply to offsite tour tickets. Offsite tour tickets are non-refundable except where a tour is cancelled in its entirety, and no suitable alternative is offered.

(e) Virtual Ticket Cancellations

All virtual ticket purchases are non-refundable from the time of purchase. No cancellations, refunds or substitutions will be accepted for virtual registrations under any circumstances. The cancellation and refund tiers set out above apply to in-person conference registrations only and do not apply to virtual tickets.

2.3 Insurance

Registration fees do not include insurance of any kind. Attendees shall be regarded as carrying their own risk for personal injury or loss of property, including baggage, during the conference. We strongly recommend that, at the time of booking Your travel, You take out travel insurance policy of your choice. We are in no way responsible for any claims concerning insurance.

2.4 Force Majeure

Where a force majeure event occurs, We will use all reasonable endeavours to contact You and offer a rescheduled date or where the Event is cancelled a full, a refund of your registration fees. Should the event be rescheduled and You cannot attend, we will offer a refund of fees if notified by a specified date.

2.5 Virtual Access & On-Demand Content

The following terms apply to all delegates who have purchased a virtual ticket or have been granted complimentary on-demand access as part of their in-person registration.

(a) Live Stream Access

Virtual ticket holders will receive access to the live stream of the LambEx26 plenary stage program on Wednesday 8 July and Thursday 9 July 2026. LambEx makes no guarantee as to the uninterrupted availability of the live stream and accepts no liability for any technical interruptions, connectivity issues or quality limitations beyond our reasonable control. LambEx will use all reasonable endeavours to ensure advertised sessions are available via the live stream. However, the inclusion of individual sessions in the live stream and on-demand platform is subject to each speaker's consent and may change without notice. LambEx accepts no liability where a session is unavailable due to a speaker withdrawing consent prior to or during the event. No refunds will be provided in these circumstance

(b) On-Demand Access

Complimentary on-demand access is included for full delegate and early bird ticket holders only. Day pass holders are not entitled to complimentary on-demand access and must purchase a virtual ticket separately to access recorded content. Recorded session content will be made available on the OnAIR platform from approximately 22 July 2026. On-demand access will remain open for 90 days post-event and will

expire on 19 October 2026. No extensions to this access period will be granted.

(c) **Content Restrictions**

You must not record, screen capture, download, reproduce, share or redistribute any live stream or on-demand content in any form, whether in whole or in part. All content remains the intellectual property of LambEx and the respective speakers and may not be used or reproduced without prior written permission.

(d) **Single Device Restriction**

Virtual platform access is restricted to one registered device per login. LambEx reserves the right to revoke access without refund where this restriction is breached.

3. **Other Information**

3.1 **Photography & Videography**

Please note that photography and videography may take place during the event for promotional, educational and archival purposes. By attending, delegates acknowledge they may appear in photos or recordings. If you do not wish to be photographed or filmed, it is your responsibility to inform the photographer/videographer and move out of camera range.

3.2 **Visa Information**

All visitors travelling to Australia must have a valid visa. It is strongly recommended that Australian visa applications are lodged at least two months prior to departure from your point of origin. 3.3 **Food, Alcohol & Dietary Requirements**

While LambEx will use reasonable endeavours to accommodate notified dietary requirements, we cannot guarantee a completely allergen-free environment. Attendees are responsible for

managing their own dietary needs and food allergies.

Alcohol may be served at some Event functions and offsite tours. Attendees acknowledge that they are responsible for their own alcohol consumption and behaviour at all times.

4. **General Terms**

4.1 **Conditions of Entry**

By registering for the Event, You agree to conduct yourself in a professional, respectful manner, avoiding any behaviour that could be considered discriminatory, harassing, or harmful. Misconduct may result in removal from the Event without refund. It is a condition of entry that no delegate may disrupt the order of events or intent of the program. Anyone considered to be disturbing the program intent will be asked to leave.

You must at all times comply with the terms and conditions of entry regarding the venue hosting the Event, and with any lawful direction given by its authorised personnel.

In addition, compliance with the [Arinex Code of Conduct](#) is a condition of entry. Any breach of the Code of Conduct may result in immediate removal from the Event without refund.

The Event includes a trade exhibition and partner activations operated by third-party exhibitors and sponsors. Attendees acknowledge that they participate in any demonstrations, tastings, trials or interactive activities at their own risk. LambEx is not responsible for the products, services, advice or activities provided by exhibitors, sponsors or partners.

4.2 **Damage Cause by You**

You are liable for any damages caused by You to the Event venue, Event supplier equipment or Event organiser's equipment. In registering for the Event, You agree to indemnify us, the Event venue or Event organiser for any damages caused by You to the venue or equipment.

4.3 Release of Liability:

You release Us from liability for any losses, costs (including legal costs and disbursements) damage or claims, including but not limited to:

- (a) death or personal injury of any kind sustained by you; and
- (b) Damage to, loss of or destruction to your property

Save to the extent that a negligent act by LambEx or its employees has directly caused the loss or damage so occasioned.

4.4 Disclaimer

Every effort is made to ensure that the contents of the registration information are correct. We reserve the right at any time to change the format, participants, content, location and timing or any other aspect of the Event. The organisers retain the right to make changes where necessary. As the owner of LambEx, 28 National Limited, will not be liable to You for any damages, costs, losses or expenses of any kind incurred or suffered by You as a result of or in relation to LambEx modifying, the Event or any part of the Event.

4.5 Offsite Tours

Indemnity

I acknowledge that participation in LambEx26 pre and post offsite tours and activities between 6–10 July 2026 involves inherent risks, including but not limited to transport, physical activity, and environmental hazards. I voluntarily assume all risks and agree to release and indemnify LambEx and its affiliates from any claims for injury, loss, or damage arising from my participation, except where caused by gross negligence or wilful misconduct.

I confirm I am physically fit for my selected activities and have proactively disclosed any relevant medical conditions to lambex@arinexgroup.com. I consent to emergency medical treatment if required and understand that personal travel insurance is strongly recommended.

Biosecurity Compliance

Attendees participating in on-farm tours must comply with all biosecurity, animal welfare and property access requirements as directed by LambEx, tour operators and property owners. Failure to comply may result in removal from the tour without refund.

Program Changes and Substitutions

LambEx26 offsite tours are operated by third-party suppliers and involve transport, farm visits, tourism operators, hospitality venues and other external providers.

While every effort will be made to deliver the advertised tour program, LambEx reserves the right to vary, substitute or amend any offsite tour itinerary, inclusions, venues, suppliers, timing or routing at any time due to circumstances beyond reasonable control, including but not limited to:

- adverse weather conditions
- supplier withdrawal or closure
- safety concerns
- venue unavailability
- transport or logistical disruptions
- biosecurity or animal welfare considerations

If a supplier or venue withdraws or becomes unavailable, LambEx will use reasonable endeavours to source a suitable alternative of comparable standard and experience. By purchasing an offsite tour ticket, you acknowledge and accept that tour programs are subject to change and that substitutions may occur. No refunds will be provided as a result of tour changes, substitutions or itinerary variations.

If an offsite tour is cancelled in its entirety and LambEx is unable to offer a suitable alternative tour option, a refund of the offsite tour ticket price will be provided.

4.6 Accommodation

Accommodation is the responsibility of each Attendee. LambEx has partnered with Accommodation Link to offer a range of accommodation options within walking distance of the Adelaide Convention Centre at discounted

4.7 Marketing and Promotion

Promotional or marketing materials may not be distributed at the Event except by Event partners, sponsors and exhibitors in accordance with their partner or exhibitor agreement or otherwise with the written consent of Us. Attendees violating this policy may be required to leave the Event immediately and will not receive a refund.

4.8 Intellectual Property

All intellectual property rights in and to the Event content and all materials distributed at or in connection with the Event are owned by Us and/or Event exhibitors, partners, or speakers. Attendees may not use or reproduce or allow anyone to use or reproduce any materials distributed at or in connection with the Event for any reason without the prior written permission of LambEx or the Event exhibitors, partners or speakers (as applicable).

For the avoidance of doubt, this includes all live streamed and on-demand content accessible through the LambEx26 virtual platform. Attendees and virtual delegates must not record, screen capture, download or otherwise reproduce any virtual or on-demand session content without the prior written permission of LambEx.

4.9 Merchandise

Any merchandise or products supplied or purchased at the Event are supplied by third parties and not LambEx. We do not take any responsibility for any acquisition for merchandise, or business curated at the Event.

4.10 Privacy Policy

When You register to attend the Event, You consent to the collection of Your personal information to process your registration, in accordance with the [Arinex Privacy Policy](#). If you do not provide or we cannot otherwise collect all the information we request or need, we may not be able to register You for the conference.

We may disclose your personal information to our third party suppliers (such as Event organisers and the Event venue), and to third-party software providers.

We may with your consent where required, use your contact details to send you (by telephone, post, email or SMS) marketing communications about our programs, products, services, promotions and events. You can opt out of marketing communications at any time, by particular means or at all, by following the unsubscribe function in the message we send, or by emailing or calling us.

We are not responsible for the subsequent use, disclosure or handling of your personal information by any exhibitor or any other person who obtains your personal information using electronic scanning software or if you otherwise provide your personal information to a third party during an Event (for example, if you provide your email directly to third party).

4.11 Lead Capture & Data Sharing

Attendees acknowledge that by allowing their badge to be scanned by exhibitors or sponsors, their personal information will be shared directly with that exhibitor or sponsor and will be subject to that party's own privacy policy.

4.12 Changes to the Terms & Conditions

LambEx reserves the right to make reasonable amendments to these terms and conditions from time to time. LambEx will publish the amended terms and conditions on LambEx's website and will provide You 10 days written notice that these terms and conditions will be amended and from when the amendments will apply. The then current version of the terms and conditions will apply. Written notification does not need to be made to You specifically and can be made by displaying a notice of the upcoming change on LambEx's website or through a broadcast email or other form of message to all Attendees.

You will be subject to the terms and conditions in force at the time You register for the Event, and

any amendments to these Terms will not apply retrospectively.

4.13 Jurisdiction

These terms and conditions are governed by and are to be construed in accordance with the laws of ACT, Australia. Each party submits to the non-exclusive jurisdiction of the courts of ACT.
